



# LeRoux School of Dance Recital Policies 2012



Since dance is a performance art, participation in our annual recital is recommended, however, it is not mandatory. Children participate in all aspects of their weekly classes, regardless of recital participation.

**RECITAL FEE:**

A recital fee was established in lieu of an annual advertising drive. Recital fees cover production costs associated with the recital and provide the following services to our families at a discount: CD of edited recital music for rehearsal outside of class time; professional DVD of the recital which includes our photo montage; recital t-shirt with theme artwork; memory mate (class photo and individual portrait) complete with recital artwork; AND 4 tickets to the recital. Deposit of \$75 due October 15<sup>th</sup>; \$50 balance due March 15<sup>th</sup> (refund policy details are available upon request).

**For families with multiple dancers:** Additional dancer's recital fee is \$35 and provides rehearsal music, recital t-shirt and photo memory mate. This payment is due March 15<sup>th</sup>, no deposit in October is needed.

**RECITAL COSTUMES:**

Our costume authorization form must be completed, signed and returned with a costume deposit. Your costume deposit is equivalent to \$35.00 per class. The number of costumes required will be indicated on the authorization form provided the during our November visitation week. All costume balances are due in full by January 15<sup>th</sup>.

**RECITAL ELIGIBILITY:**

- All students enrolled in level Children's Dance 1 through Advanced, hip hop, lyrical and musical theatre are eligible to perform in the recital.
- Student usually perform one dance for each style of dance in which they are enrolled (ballet, tap, jazz, etc.). Exceptions to this policy are related to level and number of classes attended each week.
- Students who join our program after December 1<sup>st</sup> must have teacher approval before electing to participate in the recital. Minimum four weeks enrollment is required prior to discussion or approval.

**RECITAL FINANCIAL COMMITMENT:**

- Recital Fee: \$125.00 for first dancer; Sibling Fee: \$35.00 each
- Purchase costumes for each dance; pricing is below.
- Student may choose not to participate in all dances offered for their class, however only tap and jazz are optional in combination classes. This decision should be discussed with your teacher.
- **Costume Fees for 2012**

Child Costume (size small, intermediate or medium)	\$52.00
Child Costumes (size large)	\$55.00
Child 2-in-1 Costumes (size small, intermediate or medium)	\$80.00**
Child XL or Adult Costume (size small, medium or large)	\$65.00
Adult XL or 2XL (size 16A -20A)	\$75.00

**2-in-1 Costume Description:** The same bodysuit for two dances, accessorized differently for each number (tutu, skirt, pants, headpieces, etc.)

- **Admission Fees** are as follows, if additional tickets are needed:
  - Adult Tickets: \$12.50 each
  - Child Tickets: \$10.50 each
- Seating assignment is done by lottery. Ask for more details if this is your first recital.
- Due to fire codes, a ticket must be purchased for each person, regardless of age.

**RECITAL DATES & LOCATION:**

- **Recital 2012 will be held at Spring-Ford 9<sup>th</sup> Grade Center –6/9/2012**
- Dress Rehearsal attendance is mandatory. Dress Rehearsals are scheduled for **Thursday, June 7<sup>th</sup> or Friday, June 8<sup>th</sup>**. Recital and Rehearsal times will be provided with the February 15<sup>th</sup> update.
- Parents and other visitors are not permitted in the dress rehearsal or dressing areas at the recital. Students are well taken care of at all times by experienced staff.
